We write in relation to the disclosures of SMC Global Power Holdings Corp. ("SMC Global Power"), dated 29 August 2017 and 25 September 2017, in connection with the consent solicitation of SMC Global Power for the proposed amendments to the Trust Agreement dated 23 June 2016 (the "Trust Agreement") covering its Series A Fixed Rate Bonds due 2021, Series B Fixed Rate Bonds due 2023, and Series C Fixed Rate Bonds due 2026 (collectively, the "Bonds") ("Consent Solicitation").

We advise that, based on the results of the Consent Solicitation, bondholders of record holding at least 51.99% of the aggregate principal amount of the Bonds have given their consent to the proposed amendments to the Trust Agreement.

In this regard, on 11 October 2017, SMC Global Power and Philippine National Bank – Trust Banking Group (as Trustee for the Bonds) executed the Amendment Agreement which sets out the amendments to the Trust Agreement.
