Re: Complaints for Plunder and Corruption against Lourdes Alzona, Suguru Tzusaki, Team (Philippines) Energy Corp. ("TPEC"), Koichi Tamura and Team Sual Corporation ("TSC")

Further to our disclosure dated October 12, 2016 relating to the above-captioned subject, we advise that the Department of Justice ("DOJ") issued a Resolution, dated 25 October 2017, partially granting the Petition for Review filed by respondents Suguru Tsuzaki, TPEC, Koichi Tamura and TSC by ruling that the "assailed Resolution is REVERSED AND SET ASIDE insofar as the conduct of preliminary investigation." The resolution further affirmed the transmittal of the records of the case to the Office of the Ombudsman for its disposition. San Miguel Energy Corporation ("SMEC") shall be filing a motion for partial reconsideration of said Resolution.

In connection with the pending civil complaint filed by SMEC with the Regional Trial Court Branch 71, Pasig City (the "Court"), on 05 July 2017, SMEC consigned with the Court the additional amount of Php16,185,640.73 corresponding to the proceeds of the WESM sale of the "excess capacity" for the billing period from 26 July 2016 to 25 August 2016. SMEC also filed a Motion to Admit Second Supplemental Complaint in relation to said consignation. To date, the total amount consigned with the Court is Php 491,242,288.90.
