Re: Complaints for plunder and corruption against PSALM, TPEC and TSC

Further to our disclosure in our Prospectus dated June 23, 2016 relating to the abovecaptioned subject, we advise that the Department of Justice ("DOJ"), in its Resolution dated 29 July 2016, found probable cause to file Information against certain officers of Power Sector Assets and Liabilities Management Corporation ("PSALM"), Team Philippines Energy Corporation ("TPEC") and Team Sual Corporation ("TSC") for Plunder and violation of sections (e) and/or (f) of RA 3019 in connection with the illegal grant of the so-called "excess capacity" of the Sual Power Station in favor of TPEC. The DOJ further resolved to forward the entire records of the case to the Office of the Ombudsman for their proper action.

On 3 October 2016, SMEC filed an Omnibus Motion (To Admit Supplemental Complaint and To Allow Future Consignation with Tender) with the Regional Trial Court Branch 71, Pasig City ("Court"). This Omnibus Motion is in relation to the civil complaint for consignation filed by SMEC against PSALM arising from PSALM's refusal to accept SMEC's remittances corresponding to the proceeds of the WESM sale of the electricity generated from the "excess capacity." SMEC consigned with the Court the additional amount of Php280,190,640.05 corresponding to the proceeds of the WESM sale of the "excess capacity" for the billing periods from 26 April 2016 to 25 July 2016.
