Re: Dispute between South Premiere Power Corp. and Power Sector Assets and Liabilities Management Corporation

Further to the disclosure of SMC Global Power Holdings Corp. in its Prospectus dated 08 December 2017, we advise that the Court of Appeals in its Decision dated 19 December 2017 denied the Petition for Certiorari filed by Power Sector Assets & Liabilities Management Corporation ("PSALM") and affirmed the following orders issued by the Regional Trial Court, Branch 208 of Mandaluyong City: (a) Order dated 28 September 2015 which granted the issuance of Writ of Preliminary Injunction against petitioner PSALM; (b) Order dated 19 October 2015 which granted respondent Manila Electric Company's intervention in the case; and (c) Order dated 07 June 2016 which denied PSALM's Motion's for Reconsideration of the aforesaid orders.
