Further to the disclosure of SMC Global Power Holdings Corp. (the "Corporation"), dated 25 June 2019, we advise that the Corporation, on 3 July 2019, issued U\$\$300,000,000 Senior Perpetual Capital Securities as a result of the additional subscriptions received by the Corporation (the "Additional Securities"), which shall be consolidated into and form a single series with the Corporation's existing U\$\$500,000,000 Senior Perpetual Capital Securities issued on 25 April 2019 (the "Original Securities" and together with the Additional Securities, the "Securities"), and accordingly, the aggregate principal amount of the Securities outstanding is U\$\$800,000,000.

Credit Suisse (Hong Kong) Limited, Merrill Lynch (Singapore) Pte. Ltd., and UBS AG Singapore Branch are the joint lead managers for the Additional Securities.

Approval in-principle has been obtained from the Singapore Exchange Securities Trading Limited (the "SGX-ST") for the listing and quotation of the Additional Securities and the Additional Securities are expected to be admitted to the Official List of the SGX-ST on 4 July 2019.
