Re: Petition to Nullify ERC Resolution No. 1, Series of 2016

Further to the disclosure made by SMC Global Power Holdings Corp. (the "Corporation") relating to the above-captioned subject on 22 May 2019, we advise that, the Supreme Court En Banc issued a notice, dated 23 July 2019 (the "Notice"), a copy of which was received by the Corporation on 13 August 2019. The relevant portions of the Notice states, as follows:

"Acting on the following motions for reconsideration of the Decision dated May 3, 2019, the Court Resolved, by the same vote and with Associate Justice Henri Jean Paul B. Inting joining the majority, to **DENY WITH FINALITY** the said motions for reconsideration as the basic issues raised therein have been passed upon by this Court and no substantial arguments were presented to warrant the reversal of the questioned Decision:

- (a) Motion for Reconsideration dated June 31, 2019 [should be May 31, 2019] filed by the Office of the Solicitor General (OSG) for public respondent Energy Regulatory Commission (ERC); and
- (b) Motion for Reconsideration dated June 4, 2019 filed by counsel for respondent Panay Energy Development Corporation (PEDC)."
